The NFPF is the nonprofit created by Congress to save America's film heritage. Working with archives, the NFPF preserves American films, improves access for education and exhibition, and encourages film as art, history, and cultural resource.

Preserving American films through grants. Saved 96 films through cash grants to 43 archives, historical societies, libraries, museums, and universities. Among the films slated for preservation were Corn's-A-Poppin' (1955), co-written by Robert Altman; The Masters of Disaster (1985), profiling an inner-city chess club; Terry Ramsaye's Thirty Years of Motion Pictures (1927); and home movies of pioneering women's pro baseball team the Rockford Peaches, CCC projects in Oklahoma and Kentucky, and American WW2 operations in North Africa. The grants are open to American nonprofit and public organizations of all sizes and experience levels. Projects are selected by expert panels. Films preserved through NFPF grants are made available for education and shared with the public via screenings, exhibits, DVDs, broadcasts, and the web. The NFPF website showcases select examples from the program.

Repatriating American films unavailable in the U.S. The NFPF completed a collaboration with the New Zealand Film Archive and 5 U.S. archives to preserve 176 American silent films found in New Zealand. Selected films are available on the NFPF website. Also completed was the preservation and repatriation of Too Much Johnson (1938), created by Orson Welles for the Mercury Theatre. Thought destroyed, Too Much Johnson was unearthed in Italy by Cinemazero and preserved through a grant to George Eastman House. It has screened worldwide and will be released online. The NFPF embarked on a partnership with the Netherlands's EYE Filmmuseum. Films were selected for preservation by archivists and scholars. The NFPF is managing the overall project which continues through 2017.

Promoting film preservation through publications. The NFPF produces the award-winning Treasures DVD series presenting American films preserved by archives and previously unavailable on video. The sets are used in libraries and universities around the world. In 2013 the NFPF released Lost & Found: American Treasures from the New Zealand Film Archive, an anthology of repatriated gems from the international collaboration. It received a Heritage Award from the National Society of Film Critics. We pressed ahead with Treasures 6: Next Wave Avant-Garde, surveying experimental filmmakers who rose to prominence after 1965. In addition, we continued to distribute our Film Preservation Guide (2004), which can be downloaded free or mailed on request. The award-winning primer has been translated into 3 languages. Our Field Guide to Sponsored Films (2006) is also distributed through these channels.
